**Subject: Agenda Item 9A – April 5, 2018 Board Meeting
District /CAL FIRE Chief Report for February 2018 and March 2018**

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 123 calls in February, including 79 Medical Aids and 2 Traffic Collisions; 14 incidents were reported as Fire, 5 as Hazardous; 19 as Public Service Assists.
2. Company 15 was called to cover the station or respond to emergencies in the month of February a total of 6 times.
3. Station 15 - South Bay responded to 105 calls between March 1-26, including 63 Medical Aids and 4 Traffic Collisions; 10 incidents were reported as Fire, 6 as Hazardous; 17 as Public Service Assists.
4. Company 15 was called to cover the station or respond to emergencies in the month of March a total of 10 times.

ADMINISTRATION

5. The eight prospective Station 15 – South Bay Reserve Firefighter candidates continued completing steps needed to become employees of the LOCSD. In February, all of the candidates successfully completed their required shadow shifts and were released to full duty as a Company 15 Reserve Firefighter.
6. Throughout February and March, CAL FIRE/Station 15 – South Bay Fire Staff applied for multiple grants, with two being successful, 1 pending and 1 declined.
7. On February 1, 2018, Reserve Firefighter Peter Hardy resigned after 2 years of service to the community of Los Osos to pursue other career goals. Peter lives in Los Osos and has strong roots here. We wish Peter and his family the best!
8. On February 6, 2018, Reserve Firefighter-Paramedic Trevor Hamblin resigned with 6+ years of service to the community of Los Osos to pursue a full time position with Santa Barbara County Fire. Trevor was a great asset with his Paramedic skills, along with his surf training, allowing him to assist in many water rescues. We hope the future is full of hope and promise for Trevor and his family.

ADMINISTRATION

9. On February 28, 2018, Office Assistants Brown and Rohner attended an all-day computer software training course.
10. On March 14, 2018, the ZOLL X-Series Automatic External Defibrillator's underwent their annual maintenance checks, conducted by ZOLL Medical Corp. personnel. All AED units passed inspection.

SPECIAL PROGRAMS/PROJECTS

11. In February, 2018, CAL FIRE/Station 15 – South Bay Fire applied for and was awarded a grant through the SLO County Community Fire Safe Council to fund a Community Chipping Event within Los Osos. The grant award is for \$11,500 with an in-kind match of \$11,500. Staff is organizing two separate events: The first is a 5-day door-to-door chipping event that will occur May 7-10 with a focus on the Cabrillo Estates area and the southern roadways on Highland Drive and Las Encinas Drive. The second event is Neighborhood Chipping and will occur on May 5-11; participants can drop off their debris at two different locations in town. 12. In February, CAL FIRE/Station 15 – South Bay Fire Staff began preparations to host a “Family and Friends” CPR Class to be held on May 13th from 6-8:30 pm at the South Bay Community Center. This is a free course to Los Osos residents who are 16 years of age or older. “Friends and Family” CPR teaches Hands-Only CPR, CPR with breaths and clearing airway blocks.

Family & Friends CPR is for people who want to learn CPR but do not need a CPR course completion card to meet a job requirement. This course is ideal for community groups, new parents, grandparents, babysitters, and others interested in learning how to save a life. 13. On February 6, 2018, CAL FIRE/Station 15 – South Bay Fire taught a First Aid/CPR Course to Los Osos Pack 214's Webelos Cub Scout troop of 16 boys, ages 10-11 years old.
14. On February 15, 2018, CAL FIRE/Station 15 – South Bay Fire Staff hosted the Wishing Well School for a tour of the Firehouse. Approximately 15 kids, ages 6-8 years learned about home fire safety, climbed in the fire engine and discovered what a “Day in the Life” of a firefighter is like.
15. On March 19, CAL FIRE/Station 15 – South Bay Fire was awarded a \$500 grant from State Farm Insurance and the National Fire Protection Association. This award assists in the education of the community on May 5, 2018, which is recognized as Wildfire Preparedness Day. Staff is in the process of acquiring posters, signs and pamphlets that will be distributed and posted throughout Los Osos to let citizens know what they can do to reduce their fire risk and local resources that are in place to help.
16. On March 22, 2018, Office Assistant Harmony Brown hosted a lunch meeting for Administrative workers in the fire service within SLO County. Attendees learned about how geographical informational systems (GIS) has become imperative in the fire service to help determine evacuation needs, model fire behavior, aid in pre-planning, and plays a critical role in incident management.
17. CAL FIRE/Station 15 – South Bay Fire received the new Medic Squad 15 on March 23, 2018. It has been equipped with all of the proprietary emergency equipment. As the primary response engine to MDO, this new vehicle seats 4 people and is equipped with Advanced Life Support and Rescue equipment that will serve the community for many years to come.

SPECIAL PROGRAMS/PROJECTS

18. On March 23, 2018, CAL FIRE/Station 15 – South Bay Fire Staff participated in the Los Osos Chamber of Commerce Business Expo that was held at the South Bay Community Center, with the intention of educating the public regarding our upcoming Chipping Events and to showcase Medic Squad 15.
19. On March 31, 2018, CAL FIRE/Station 15 – South Bay hosted a “Birthday Party at the Firehouse” for a 4-year old local boy who won the prize at the Needs’N’Wishes Fundraiser in December. Attendees were treated to a tour of the Firehouse and Fire Engines and then enjoyed lunch and birthday cake.

TRAINING

20. From March 16 through March 18, 2018, Fire Captain-Paramedic Pearl and Fire Apparatus Engineer-Paramedics Byrne and Green along with about 25 other CAL FIRE employees attended a 24 hour Continued Professional Training course taught by CAL FIRE/SLO County Fire Department Training Staff. This refresher course trained participants in auto extrication, rescue systems for ropes and ladders, CPR Training and numerous other topics. This is the 2nd of 4 mandatory 24 hour annual training sessions for all CAL FIRE personnel.

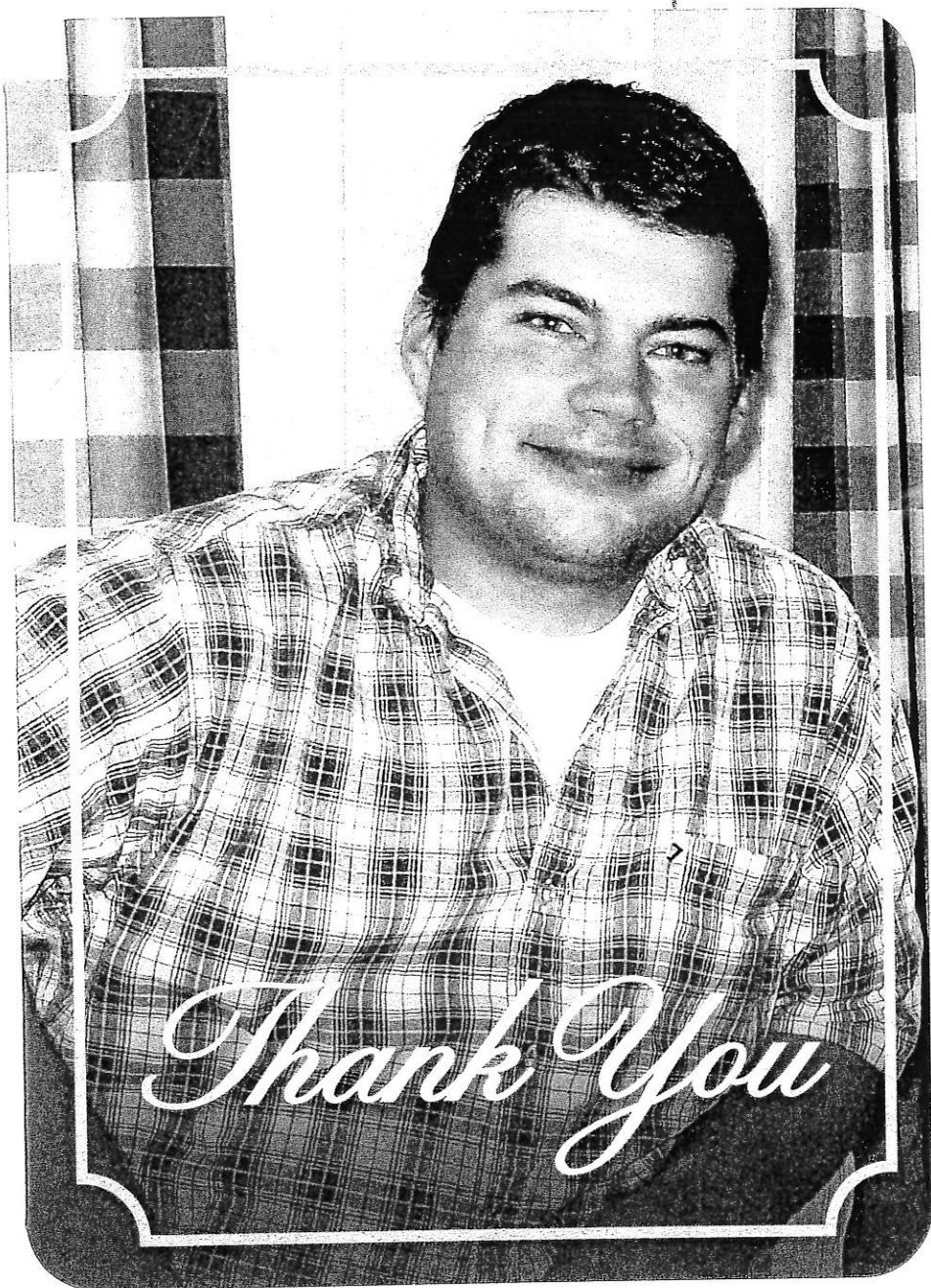
