District /CAL FIRE Chief Report for November 2020

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 157 calls between October 22 – November 21, 2020 including 75 Medical Aids, and 24 Traffic Collisions; 13 incidents were reported as Fire, 7 as Hazardous; 28 as Public Service Assists; and 10 as False Alarms.

Company 15 was called to cover the station or respond to emergencies 1 time between October 22 –November 21, 2020.

2. Station 15 – South Bay continues to respond during the COVID-19 pandemic. Crews are taking extra precautions to limit exposure during medical calls. Station 15 – South Bay is still closed to the public for non – emergency visits.

FIRE PREVENTION

3. During the month of November, Station 15 – South Bay staff continued to conduct business inspections in the District. This is an ongoing project that continues throughout the year. While San Luis Obispo County is in the purple tier these inspections will be paused.

SPECIAL PROGRAMS/PROJECTS

4. During the month of November, Station 15 – South Bay had to postpone physical ability tests and interviews for reserve firefighter applicants due to San Luis Obispo County moving back to Tier 1. 5. During November 16-19th, 2020 Chief Provence and Captain Moriarty attended Personal Watercraft Rescue Operations. In this course personal performed rescues in an ocean environment. Course covered area from Avila Pier, Cayucos Beach Pier, and Morro Bay.
6. On November 8, 2020 Station 15 – South Bay participated in making a young boy's 2nd birthday extra special with a drive by in the engine.
