DESCRIPTION

Annually, various assessments are placed on the tax rolls for collection. This report requests the Board set a public hearing for July 2, 2020, for the collection of delinquent water charges and property tax assessments on the 2020/2021 property tax roll.

STAFF RECOMMENDATION

The staff recommends that by motion the Board take the following action:

Motion: I move that the Board set a public hearing for July 2, 2020, to receive public testimony on authorizing collection of charges for delinquent water charges and property tax assessments on 2020/2021 property tax bills.

DISCUSSION

By approving the staff recommendations, the District will follow the 2020/2021 tax roll timeline provided by the County Auditor. Each year a number of ratepayers fail to pay for services the District provides. State law enables the District to collect delinquent water charges on property tax bills. Also in accordance with State law and County regulation, the District annually adopts resolutions to place various assessments on the tax rolls for collection. These include:

1. Bayridge Estates Annual Service Charge
2. Vista de Oro Annual Service Charge
3. Drainage Special Tax
4. Fire Protection and Prevention Services Special Tax
5. District No. 1 Wastewater Assessments

Staff has attached the 2020/2021 tax roll timeline and a sample of the letter the District has sent to delinquent water ratepayers.

Notices of the public hearing will be published in the Tribune on June 17, 2020 and June 26, 2020, per Government Code Section 61115(b) and 6066. Property owners with delinquent water charges were noticed to make payments by June 15, 2020. Any payments made by property owners on or before July 2nd will be deleted from the list prior to submitting to the County Auditor.

The County also adds a charge for collection to the property tax bill. As a result, the District is not charged County costs. Coordination with the County on delinquent accounts is cost effective and promotes well governed communities.

As the property owner, and in accordance with the District Code, please remit \$_____ payable to LOCSD, not later than 5:00 p.m. on Monday June 15, 2020 or the amount of the charges, penalties and delinquencies may be filed with the County Auditor to be placed on the parcel's property tax bill for collections. A stamped, self-addressed envelope has been provided.

*"District Code – Title 2 – Section 2.01.05 – Responsibility of Property Owner
The owner of the property, in which services are furnished is the customer and shall be responsible for the payment of all rates, charges and fees, including penalties, thereon regarding such furnished services. Unpaid obligations shall run with the land, shall create a lien on the property, and shall lead to delinquency and termination of service for the property involved without regard to any changes of residency or occupancy by persons different than the persons shown on District records as obligated to pay said bill."*

Please be advised that should payment not be received by the above time and date, that on July 2, 2020, a public hearing to collect the above delinquent water charges on the County of San Luis Obispo FY 2020/2021 tax rolls will be held before the Los Osos Community Services District Board of Directors, at which time the Board shall hear and consider all objections or protests to the charges and/or their collection on the parcel's property tax bill.
