DESCRIPTION

The Utilities Department has surplus properties that are valued at less than \$1,000 each. Per the District's Surplus Property Disposal Policy (does not apply to real property), if these properties were valued in excess of \$1,000 they would be brought before the Board of Directors with a Surplus Resolution prior to disposition. According to the Surplus Property Disposal Policy the General Manager has authority to dispose of property at his discretion if valued at a \$1,000 or less. There were two manners used to dispose of surplus; by listing items on the open market or donate to a non-profit. The various tools and one of the vehicles were listed on Craigslist for sale. Items were listed with a price and "or best offer" specified. The District received multiple offers for the tools and for one of the vehicles. One of the vehicles was donated to the KCBX Vehicle Donation Program since it was inoperable and had deteriorated after sitting for five years.

Attached is a list of equipment, including a brief description of each, and vehicles that were sold and/or donated. Proceeds were recorded to general ledger code 4930 (other revenue) for fund 500 (water).

Will need to rebuild/replace Sold on 3/10/21 for \$800
2001 Ford F150; RWD	Donated	Engine 4.2L Essex OHV V6, 205 horsepower, 250 lb/ft of torque (per factory specs); Transmission: Mazda M5ODR2 5-speed standard, Axle: Ford 8.8, open differential, Configuration: Basic fleet trim, single-cab, short bed, rear wheel drive. Single cloth bench seat with vinyl floors and minimal gouges. AM/FM radio, manual windows, ABS. Truck is equipped with a matching camper shell. Full disclosure note: This truck was originally decommissioned due to the failure of its clutch slave cylinder, causing the clutch to be permanently engaged. The M5OD family of transmissions is equipped with an internal slave cylinder; fixing the problem requires complete removal of the transmission. Additionally, the truck has been sitting for five years. All fluids and belts should be replaced before operation, and hydraulically-operated friction components such as the clutch disc and brakes may be fused to their mating surfaces. The bench seat sports a large gouge in the foam on the driver's side. As a final note, the Canadian Essex family of V6 engines is somewhat infamous for its reliability issues; this particular example is no exception per District maintenance records. Stihl TS350 Super Cut-off Saw	\$20	Single-cylinder 2-stroke cutoff saw. Green-tagged as being in working condition as of 2006. Sold for \$20 3/8/21
