Los Osos Community Plan Comment Letter - *Background*

- Discussions regarding water issues in the LOCP with County staff began in late 2019
- The District submitted a letter of concern regarding the water issues to the Planning Commission in June 2020 for their July hearing
- The Planning Commission recommended approval of the LOCP to the Board of Supervisors in October 2020
- The Board of Supervisors will consider the adoption of the LOCP on December 15th



Los Osos Community Plan Comment Letter - *Key Concerns*

- Interpretation and use of the four metrics in the Basin Plan
- The reference to the “programs for immediate implementation” in Appendix D which are intended for existing customers, not for new development as implied
- Lack of acknowledgement that there needs to be a funding mechanism for new development to pay its fair share for past and future investments
- The need to update the County’s Recycled Water Management Plan and how the Urban & AG Reinvestment Program is referenced in the LOCP
- Reconciliation between the Level of Severity III in the RMS report and the interpretation of the Basin Yield Metric in Appendix D
