LOCAC report from 10/26/2023 Meeting

Discussion Anastasi project - LOCAC has concerns about our water basin not being able to support new development. They are also concerned that the plan does not include public amenities like green/open space or safe pedestrian routes to schools or shopping.

County and local agency reports were given.

Claire M. from County planning, Annual priorities report will be presented to the board. Title 19 adjustments are being made to the plan from the completed offset study.

Bruce Gibson's report: not a lot of Los Osos specific to report. Tentative track map Anastasi project before the board on Tuesday. It's the first agenda item. Be there by 9:30 if you want to be there in person or online for this agenda item.

Rejoining Integrated Waste Management. Previous BOS decision to leave the IWMA cost tax payers most of 1 million dollars for the county to take on Waste management themselves. Going back will, on the whole, save money. There will be some increase due to handling (diverting) the organic materials. County is leading edge because it has an anaerobic digester that gathers the methane and immediately burns it.

Late January or early February the board wants to have a housing policy, and to encourage building affordable homes. Board wants to meet production numbers set by the state with the Goal being 1600 new homes by end of 2028 (5 years). Will be a tough target to meet, but a good focusing tool to have.

Q: Andrea Lueker- Asked for updates on Advisory board questionnaire. Nov 1st Wind energy meeting. How will the Questioning go for public comment? Last meeting was poor for being able to ask questions.

Paulding and Ortiz Legg working on guidelines for advisory council's work. Close to having county wide guidelines.

Wind energy forum is an informational panel. Laird will speak on how projects organized and permitted.

Addis will address environmental impacts.

Gibson - 3 successful leaseholders and 2 reps from trade groups will discuss the wind energy projects from the business side and the community side. After that there will be 1 hour for public comment.

Permitting is on federal and state level. Impacts onshore should be minimal.

Q . John Lindt are there any projects for low priced homes in Los Osos to accommodate the workforce? Why not make it a priority to make it come to Los Osos.

A. Absolutely, a priority of mine. Working with Coastal commission to show there is a plan for water and habitat conservation. Gibson is hopeful that sometime in the next year they will have a hearing to get affordable homes in Los Osos.

Q. Molly- In terms of waiting for the community plan are multifamily and single family both addressed by this plan?

A Yes.

Q Larry: heard anything about developers offering water companies money for a third well? A: BMC is looking at having a 3rd well on someone's property on the east side of town.

The fact that a property owner provide land doesn't mean development will happen. People on waitlist will have priority over developers.

Q. Linde Owen inquired about an update on Kansas on Oklahoma, until there is a place to move to can ordering people to leave be reconsidered? Can CSD get reimbursed for the removal of the rubber chips? County said it had 3 more years of use.

A: County is providing incentives help people leave with placement help and \$1000 cash to help find suitable alternative. Whether it was a place in the park where RV's can be relocated or moved into a rental. Target for closure is still early next year. It's an old landfill not suitable for long term residential use. No, rubber chip project will not be reimbursed to the CSD. That was a community decision to remove the chips.

Q Chris: re Anastasi project. developer had water in place why is the sustainability director taking a position on this when BMC is not taking a position?

A. Director was making a comment on whether there was enough water availability. Will serve letter is a decision made by Golden state water not the county. Observation that hydrologic production occurs at roughly 80% of sustainable yield. Safe yield on the basin is not being exceeded.

Comment from Patrick: Sustainable yield is not being based on good data, just assumptions.

Q. What is the incentive for a private property owner to provide land for a well?

A . Land could be taken by imminent domain or the property owner could come to terms that the owner wants they could choose to lease or sell the property.
