WATER PRODUCTION INFORMATION

The total production for the month of June 2017 was approximately 17.2573 million gallons (MG) this equates to an average daily demand of 575,243 gallons. This represents an increase in production from last year by approximately 10.10%.

Using the state's formula to calculate residential usage per capita per day, for the month of **June 2017** our residential customers used **77.5** gallons per person per day.

PRODUCTION AND RUNTIME HOURS BY WELL SITE

The following tables break down the production by well site and runtime on the pump motors for the month of **June 2017**. Totals for last year are included for comparison:

WATER BILLING INFORMATION

Forty three percent of the service area received bills for approximately **12.5 MG** consumption for the period May 10, 2017 through July 13, 2017. This generated approximately **\$168,526** in revenue.

UTILITIES DEPARTMENT OPERATIONS AND MAINTENANCE

During the month of June 2017, the crew provided weekly water sampling, well site rounds, read water meters, marked underground utilities, performed equipment maintenance and submitted the monthly report to the state. In addition to these duties, the crew performed maintenance to the Bayridge Drainage Basin, they repaired a water service line at 1503 16th Street, continued the valve exercise program, performed fire hydrant, sample point and meter box maintenance, repaired a water main break on the 1700 block of 15th street and performed detailed maintenance on the backhoe and vacuum trailer.
