District /CAL FIRE Manager Report for January 2013

EMERGENCY ACTIVITY

- 1. Station 15 South Bay responded to 108 calls in January with six Simultaneous Calls (Back to Back). Five of the Simultaneous Calls required Advanced Life Support. Of these 108 incidents, 76 were Medical calls with 43 requiring Advanced Life Support provided by Paramedics. Five incidents were reported as Traffic Collisions; five incidents were reported as Fires, 23 as Public Service Assists, and four as Emergency.
- 2. Company 15 was called to cover the station or respond to emergencies in the month of January a total of 8 times.
- 3. Station 15 South Bay responded to 1,259 calls in 2012 with 61 Simultaneous Calls (Back to Back). 30 of the Simultaneous Calls required Advanced Life Support. Of these 1,259 incidents, 866 were Medical calls with 482 requiring Advanced Life Support provided by Paramedics. 36 incidents were reported as Traffic Collisions; 61 incidents were reported as Fires, 263 as Public Service Assists, and 50 as Emergency.
- 4. Company 15 was called to cover the station or respond to emergencies in 2012 a total of 131 times.

ADMINISTRATION

- 5. On January 8, 2013, Reserve Firefighter Curtis Hames submitted a letter of resignation, effective immediately, due to relocation to southern California. Hames was a dependable and valuable asset to Station 15 South Bay throughout his three years of employment.
- 6. In early January, Station 15 South Bay was awarded a grant for \$10,000. This grant was submitted to the Heritage Firefighter's Fund by local landowner John A. Hamby, Managing Director of DeWitt Stern of California Insurance Services. The grant was issued to the San Luis Obispo County Fire Department, with the request that it be used to benefit emergency response in the Los Osos area. The funds, as outlined in the grant, will be used to purchase approximately 20 new pairs of boots for the firefighters, 2 laryngoscopes and approximately 35 CO Detectors to be issued to low-income families and senior citizens on a first come-first served basis, free of charge.

TRAINING

- 7. From January 7 through January 11, Fire Apparatus Engineer Paramedic Jenkins attended the 40 hour State Fire Marshal Fire Prevention 1B Course in Monterey. This course focuses on the codes, ordinances and statutes that pertain to fire prevention practices in California. This is the final course in a ten-course series needed by Jenkins to apply to become a State Fire Marshal Certified Fire Officer.
- 8. From January 14 through January 17, Fire Apparatus Engineer Paramedic Moriarty and Fire Captain Paramedic Wilcox attended Rescue Systems III Training Structure Collapse in San Diego County as part of the SLO County Fire Department Urban Search and Rescue Team. This course bridges the training gap between the California State Fire Training Rescue Systems 2 Advanced Rescue Skills course and the Federal Emergency Management Agency Structural Collapse Technician course. Key topics include: powder actuated tools, pneumatic shores, additional tools and techniques for breaking and breaching, cutting a tensioned cable, the "O" course, rigging and crane operations.
- 9. On January 16, Company 15 took a 4-Hour CPR Refresher Class as part of their annual training certifications. This course was taught by *CAL FIRE* employees and provided free of charge.
- 10. From January 22 through January 24, Fire Captain Paramedic Wilcox attended the Continued Professional Training Course. This 24-hour course covers a variety of topics from annual refreshers to improved fire suppression tactics for the community. Topics included mobile data computers (MDC), mapping abilities, SRA Fee, Diablo Canyon Nuclear Power Plant annual refresher, CPR Training, Gas/Utility Line Safety and New Generation Command System (NICS) Training.

SPECIAL PROGRAMS/PROJECTS

- 11. The prospective Station 15 South Bay Reserve Firefighter candidates continued completing steps needed to become employees of the LOCSD. In January, all of the candidates successfully completed a medical evaluation and were cleared by a doctor to be Fit Tested for Self Contained Breathing Apparatus as required by OSHA as well as to work for the LOCSD. Each candidate was issued a department uniform and personal protective equipment (turn-outs). In addition, students completed registration for several courses, such as the Paid Call Firefighter Academy, Confined Space Awareness, Emergency Medical Responder and CPR.
- 12. The Hurst Tool on Medic Rescue 15, or sometimes called the "Jaws of Life" equipment received its annual maintenance check. This check includes servicing hoses, hydraulic fluid, testing the strength of the motor and tools, and several other items. The service technician reported that the tools are in good condition, especially for being 20+ years old.
- 13. On January 19, members of the Estero Bay Community Response Team including the Los Osos Group attended a CERT Training Drill in Cambria hosted by PG&E. This training included important safety information for CERT members that can protect them and the public in the event of a utility-related emergency.

FIRE PREVENTION

14. On January 21, a Girl Scouts Troop tour of Station 15 – South Bay, including fire apparatus, was held with 8 children in attendance. Activities included demonstrations of "Stop, Drop, Cover Your Face and Roll" and Escape Drills In The Home (EDITH). Children were provided with a fire prevention bag with both children and adult information included.


