Authorize Station 15 - South Bay Hose Tower Refurbish Project

DESCRIPTION:

Authorize the refurbishing of the Station 15 - South Bay Hose Tower including disassembly of the Hose Tower in an effort to repaint, replace old lights with low watt LED lights and minor repairs to hardware and components along with cosmetic cement repairs to the cement near the base of the tower.

STAFF RECOMMENDATION:

Motion: I move the Board of Directors authorize the General Manger to execute the agreement with Sunrise Coating to refurbish the Hose Tower located near the Apparatus Bay at Station 15 – South Bay, install low watt LED Lights, and complete minor cosmetic cement work near the base of the tower not to exceed \$11,161.

DISCUSSION:

In 2010 a cement repair project was completed at the rear of the fire station. During this project, District Engineer Rob Miller evaluated the Hose Tower and recommended that some maintenance be completed on the tower within "the next several years". The recommended maintenance included new paint and some cosmetic cement work near the base of the tower to keep water from pooling near the metal structure. Staff budgeted for this repair within the Fund 301 FY 2014/15 and evaluated the tower in December of 2014 and January 2015.

Staff recommends the following steps be taken:

- Use a crane to remove the tower from its foundation, place it on its side on blocks near the Trench Rescue Prop
- Staff will remove light fixtures and other items
- Staff will make minor repairs to metal structure and hardware
- Hire a contractor to prepare and paint the Hose Tower
- Use a crane to replace the tower on its foundation
- Staff will add low watt LED light fixtures to the tower
- Staff will make cosmetic repairs to the cement near the base of the Hose Tower

To complete these steps, Staff has obtained the following quotes:

Crane Service:

Tutt Tree and Crane Services: This is a local vendor who provided this same work on the tower when it was first placed in service. This vendor provided a verbal quote of less than \$900 to remove and replace the tower.

Paint Contractor:

Three vendor quotes were received. All vendors were directed to use the same Sherwin Williams products specified by Station 15 – South Bay Staff. These three local vendors have provided similar work on the central coast using Sherwin Williams's products, per the local Sherwin Williams representative.

Sunrise Coatings: \$8,761 (Option A)

\$8,219 (Option B)

Bayside Painting: \$9,910 Pro-Coatings: \$9,989

Staff recommends Sunrise Coatings Option A.

Staff has researched low watt LED light fixtures, epoxy cement and other miscellaneous hardware that may be needed during this project. Staff estimates that in total these items will cost less than \$1,000.

Finally, Staff requests a \$500 contingency to be used only if needed to complete this project.

During the time period that the Hose Tower is out of service, Staff will use parking areas in the front of the station as well as the upper parking lot to wash and dry the fire hose. No interruptions of service are anticipated during this project.

FINANCIAL IMPACT:

This year, staff added \$20,000 to FY 2014/15 Fund 301 Line Item 9076 - Capital Outlay and \$8,200 to Line Item 7252 – Misc Hardware for several projects. In Line Item 9076, staff allocated \$10,000 for the Hose Tower painting project and in Line Item 7252 staff added \$1,161 for the hardware and light fixtures.

This project was discussed at the May 20, 2014 ESAC meeting during the Fund 301 FY 2014/15 Budget Preparation. The ESAC's recommendation to the LOCSD BODs to approve this submitted budget included their recommendation to the BOD for this project. The ESAC again discussed this project at its January 20, 2015 meeting and reaffirmed their recommendation to the LOCSD BODs to approve this expenditure.
